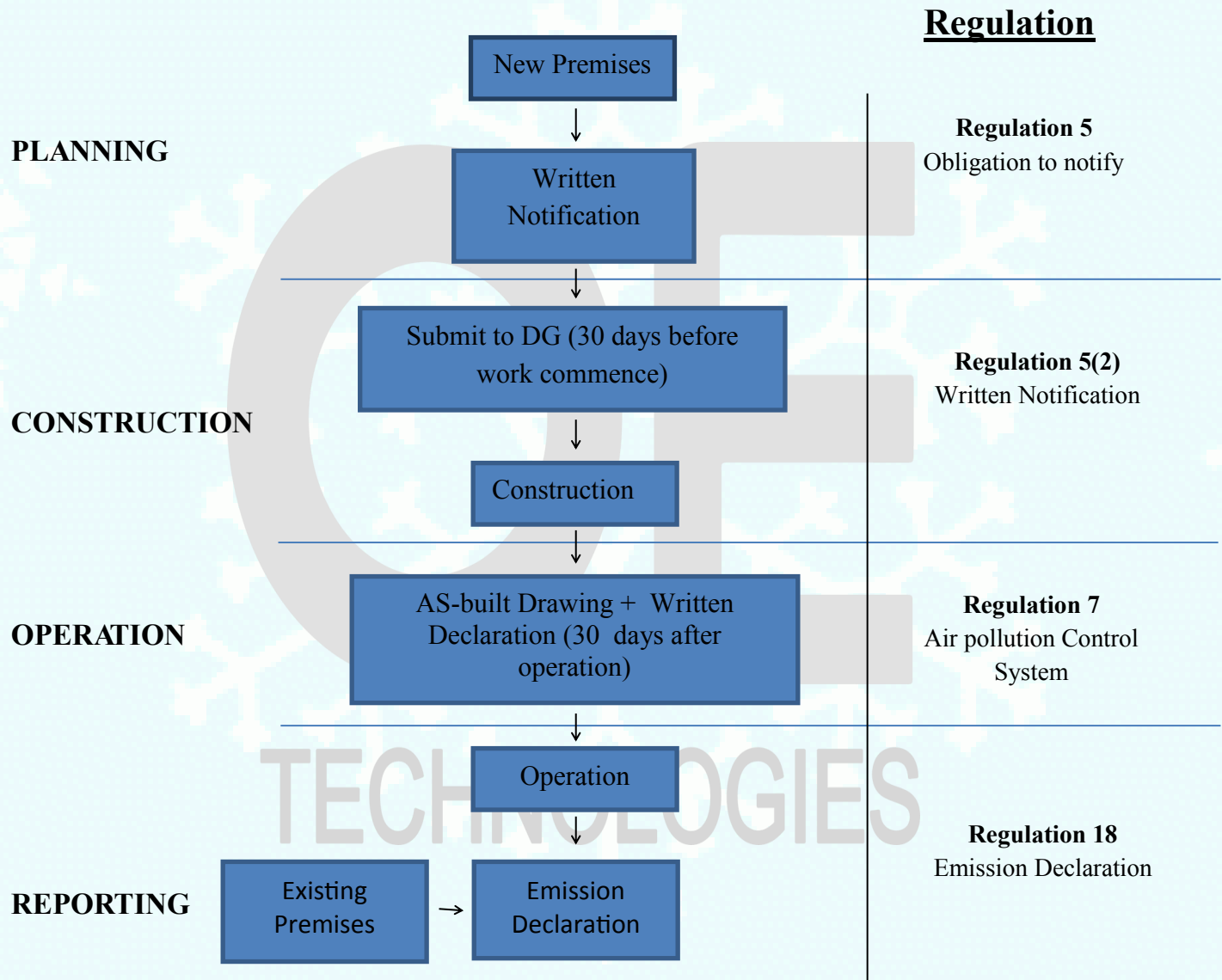

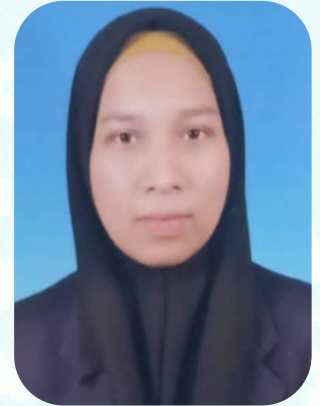
### **Mohd Hasri bin Omar, Bsc. Environmental Management (UNIVERSITY OF MALAYA)**



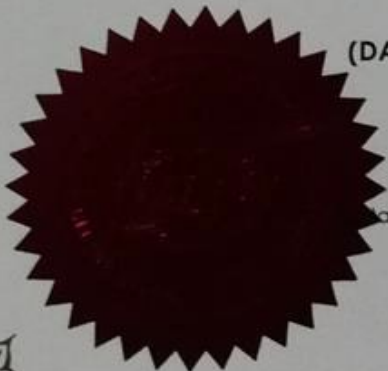

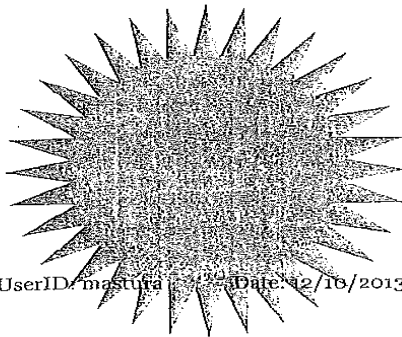
